Identification Code Types

Code 001 Identifying Individuals

For example: Name, title, address, office address, previous address, home telephone number, cell phone number, instant messaging account, internet web account, postal and resident address, photograph, fingerprint, email address, digital signature, serial number of certificate card, certificate serial number, record providing internet identity authentication or applying for inquiry service, and any other data that can be used to identify the data subject

Code 002 Identifying Financial Information

For example: Financial institution account numbers and names, credit card or debit card numbers, insurance policy numbers, and any other personal numbers or accounts, etc.

Code 003 Identifying Government Information

For example: Personal ID card number, certificate identity number, tax registration number, insurance certificate number, disability manual number, retirement certificate number, passport number, etc.

Characteristic Code Types

Code 011 Personal Description

For example: Age, gender, date of birth, place of birth, nationality, voice, etc.

Code 012 Physical Description

For example: Height, weight, blood type, etc.

Code 013 Habits

For example: Smoking, drinking, etc.

Code 014 Character

For example: Comments or opinions on character, etc.

Family Code Types

Code 021 Family

For example: Single or married, name of spouse or cohabitant, cohabitant's name of former spouse or former cohabitant, wedding date, and number of children, etc.

Code 022 Marriage History

For example: Details of previous marriage, cohabitation, divorce or separation and the names of the relevant parties, etc.

Code 023 Details About Other Family Members

For example: Offsprings, dependents, other family members or relatives, parents, cohabitants and relatives living abroad or in mainland China, etc.

Code 024 Other Social Relationships

For example: Friends, colleagues and other relationships outside of family, etc.

Social Conditions Code Types

Code 031 Residence and facilities.

For example: Address of residence, type of facility, owner or tenant, period of occupancy, rent or tax rate and other household expenditures, type and value of the residence, and name of owner, etc.

Code 032 Property

For example: All movable or immovable property or other property which data subject has rights on.

Code 033 Immigration

For example: Passport, work permit, proof of residency, residence or travel limitations, entry conditions and other relevant details, etc.

Code 034 Travel and Other Migration

For example: Previous emigration, travel details, foreign passports, proof of residency documents, work permits, work certificate and other related details, etc.

Code 035 Recreational Activities and Interests

For example: Hobbies, sports and other interests, etc.

Code 036 Lifestyle

For example: Types of consumer goods and details of services used, personal or family consumption patterns, etc.

Code 037 Membership in Charities or Other Associations

For example: Clubs or other voluntary associations, or organizations with participant records.

Code 038 Occupation

For example: School principal, elected representatives or other occupations, etc.

Code 039 Licenses or Other Permits

For example: Driver's license, vehicle license, license for self-defense firearms, fishing license, etc.

Code 040 Accidents or Other Incidents and Related Circumstances

For example: Subject of accident, nature of damage or injury, parties and witnesses involved, etc.

Code 041 Courts, Public Prosecutor's Office or Other Adjudicative Bodies or Proceedings

For example: Information about litigation and civil or criminal proceedings against the data subject.

Code Types for Education, Examination, Skills or Other Specialties:

Code 051 School Records

For example: Universities, colleges or other schools, etc.

Code 052 Qualifications or Skills

For example: Academic qualifications, professional skills, special licenses (such as pilot's license, etc.), governmental vocational training process, national examinations, test scores, or other training records, etc.

Code 053 Membership in Professional Associations

For example: Membership category, membership record, records of participation.

Code 054 Occupational Expertise

For example: Expert, scholar, consultant, etc.

Code 055 Membership in Committees

For example: Details of committees, working groups, and memberships based on expertise.

Code 056 Works

For example: Books, articles, reports, audiovisual publications and other works, etc.

Code 057 Record of Students (apprentices), Examinees

For example: Learning process, relevant qualifications, exam training assessments and results, ratings or comments or other learning or exam records, etc.

Code 058 Work Records of Committee Members

For example: Records of members' participation in propositions, grading or reviewing, oral examinations and other exam-related work.

Employment Code Types

Code 061 Current Employment Status

For example: Employer, job title, job description, grade, date of employment, working hours, work location, industry characteristics, conditions and duration of employment, previous responsibilities and experience with existing employer, etc.

Code 062 Employment History

For example: Date, method of employment, employed through intermediary/referral, period of employment, etc.

Code 063 Resignation

For example: The date of, the reason for, and the notice and conditions for resignation, etc.

Code 064 Work Experience

For example: Previous employers and work, periods of unemployment and military service, etc.

Code 065 Work and Attendance Records

For example: Records of starting and ending time, personal leave, sick leave, vacation, maternity leave, leave of absence, on-the-job records or reasons for not working, performance appraisal records, records of rewards and punishments, information of deprivation of civil rights, etc.

Code 066 Health and Safety Records

For example: Occupational diseases, records of safety and accidents, first aid qualifications, travel emergencies information, etc.

Code 067 Memberships in Labor Union and Prerequisites for Employees

For example: Details of prerequisite of membership prerequisites, duties in the union, etc.

Code 068 Payroll and Withholdings

For example: Salaries, wages, commissions, bonuses, expenses, allowances, benefits, loans, tax payments, pension deduction, admission fee for labor union, base salary or method of salary payment, date of salary increase, etc.

Code 069 Property Held by Employee

For example: Cars, tools, books or other equipment assigned to employees.

Code 070 Details of Work Management

For example: Obligations and responsibilities, work plans, costs, personnel budget, work assignments and shifts, or time spent on work or specific work, etc.

Code 071 Details of Work Evaluation

For example: Evaluation of work performance and potential.

Code 072 Educational and Training Records

For example: Compulsory education and training for work, education and training received, qualifications or skills already possessed ,etc.

Code 073 Details Concerning Security

For example: Passwords, security numbers and authorization levels, etc.

Code Types for Financial Details

Code 081 Income, Earnings, Assets and Investments

For example: Total income, total earnings, earned income, capital and assets, savings, start date and maturity dates, investment earnings, investment income, asset expenses,

etc.

Code 082 Liabilities and Expenditures

For example: Total expenditures, rent expenditures, loan expenditures, expenditures of promissory notes and other credit instruments, etc.

Code 083 Credit Ratings

For example: Credit rating, financial status and level, income status and level, etc.

Code 084 Loans

For example: Type of loan, contractual amount, remaining amount, date of first loan, maturity date, interest payable, payment records and details of mortgage, etc.

Code 085 Foreign Exchange Transaction Records

Code 086 Credit of Notes

For example: Check deposits, personal data, bounced check information, rejected transaction information, etc.

Code 087 Allowances, Benefits, Grants

Code 088 Insurance Details

For example: Type of insurance, coverage, amount of insurance, period of insurance, expiration date, premiums, insurance benefits, etc.

Code 089 Social Insurance Benefits, Pension Benefits or any Other Retirement Benefits

For example: Effective date, amount of payments and grants received, beneficiaries, etc.

Code 091 Goods or Services Obtained by Data Subject

For example: Details of goods or services, details of loans or employment of data subject, etc.

Code 092 Goods or Services Provided by Data Subject

For example: Details of the goods or services provided.

Code 093 Financial Transactions

For example: Collection and payment amount, credit line, guarantor, payment methods, transaction records, financial guarantees or other warranties, etc.

Code 094 Compensation

For example: Details and amount of compensation requested.

Code Types for Business Information

Code 101 Data Subject's Business Activities

For example: Type of business activity, goods or services provided or used, commercial contracts, etc.

Code 102 Agreements or Contracts

For example: Concerning transactions, business, law or other contracts and agencies, etc.

Code 103 Business-related Licenses

For example: Presence or absence of licenses, license obtained by market traders, truck-drivers' license, etc.

Code Types for Health and Other:

Code 111 Health Records

For example: Medical reports, treatment and diagnosis records, test results, type of

impairment, degree, validity period, disability manual number and contact person, etc.

Code 112 Sex Life

Code 113 Race or Ancestry Origin

For example: DNA data

Code 114: Final and Binding Judgments and Administrative Sanctions Concerning Traffic Violations

For example: Contents of judgments and administrative sanctions, and other matters related to vehicle accidents, etc.

Code 115 Other Judgments and Administrative Sanctions

For example: Contents of judgments and administrative sanctions, and other related matters, etc.

Code 116 Data Relating to Criminal Suspect

For example: Circumstances of the crime, arrest warrant data, associations with known offenders, aliases, and supporting evidence, etc.

Code 117 Political Opinions

For example: Views on political issues, opinions on elections, etc.

Code 118 Member of Political Group

For example: Member of political party or the post held, etc.

Code 119 Support for Interest Groups

For example: Member or supporter of interest groups or other organizations

Code 120 Religion and Faith

Code 121 Other Faiths

Code Types for Other Kinds of Data and Information

Code 131 Retrieval of Written Documents

For example: Indexes or codes of written documents that have not been processed by automated machines, etc.

Code 132 Unclassified Data

For example: Letters, files, reports or emails that cannot be classified, etc.

Code 133 Data of Radioactive Dosage

For example: Data relating to the radiation dosage personnel or buildings were exposed, etc.

Code 134 Data of National Intelligence

For example: National Intelligence Work Act, national intelligence agent security check measures and related information, etc.
